Commission Protection

You work hard for your commissions... why not protect them? Allianz Travel Insurance's Commission Protection program allows you to prevent your hard-earned commissions from being reclaimed by the travel supplier if your client cancels their vacation plans!

How the Program Works:

Your client purchases a \$1,000 vacation from a travel supplier and purchases a qualifying Allianz Travel Insurance policy that pays 20% commission protection. After final payment, your client is forced to cancel their trip (for a covered reason). Your client files a claim with Allianz Global Assistance and is reimbursed \$1,000. You then file a claim for your lost commission and receive a check for up to 20% of the trip cost- in this case, \$200. If your client happens to insure only \$800 of their \$1,000 trip, you would receive commission protection on the \$800, or \$160.

What are the Restrictions?

- There are maximum payout amounts. Please refer to your Travel Agent Guide or sales contract to determine these amounts.
- Your client must cancel for a covered reason.
- Commission will only be protected on bookings for which final payment has been made.
- In the event of a full refund by the travel supplier, Commission Protection is not in effect.
- If you charge your client a cancellation fee, that fee will be subtracted from your Commission Protection payment.
- When a client cancels, the program requires you to refund all of the client's money including all monies returned by the travel supplier and your commission amount.
- Your client must file a Trip Cancellation claim and the claim must be payable. Commission Protection will not be paid on denied claims.
- Commission Protection is available on the insured amount of the trip.

Is There Anything Else I Need to Know?

- To qualify for the Commission Protection program, you must first sign a travel agency Participation Agreement. You are automatically enrolled in the program.
- Allianz Global Assistance automatically includes Commission Protection in some of our plans.
